SUBJECT: Proposed Legislation

TO: All House Members

FROM: Representative Larry O. Sather

In the near future, I will be reintroducing legislation (previously HB1835 of last session) concerning provisions of the Decedents, Estates and Fiduciaries Code regulating the discovery of information and records regarding actions of an attorney-in-fact. Generally, this legislation permits the Department of Aging, pursuant to its regulatory and investigative duties, when interested in the welfare of a person for whom an attorney-in-fact has been appointed to petition the court for information concerning the power of attorney. This legislation provides for notice and a hearing before the release of any information. To further protect the attorney-in-fact this legislation provides for sanctions if the discovery request is used for harassment purposes.

Currently, there is no statute which directly addresses the situation involved within this legislation. Adoption of this legislation provides for a procedure for a further independent "check and balance" on the action of an attorney-in-fact. Also, adoption of this legislation would permit many potential conflicts between the Department of Aging and an attorney-in-fact to be resolved amicably and informally without the need for litigation.

This legislation is supported by the Department of Aging and has been previously reported unanimously by the Judiciary Committee in two prior sessions.

It was re-referred to Appropriations Committee on 1/27/98. The legislation was originally introduced in the 1995-96 session by Rep. Elaine Farmer and passed by the Judiciary Committee, but never found its way to the House floor.

I am sending along a copy of the Bill Summary that I was provided and an article which addresses this issue also.

We believe that since there is no current statute on this situation that it needs to be addressed.
