**SUBJECT:** Proposed Legislation – Foster Parent Consideration Act

I will be re-introducing legislation to establish the Foster Parent Consideration Act. The legislation requires **consideration** be given to foster parents if they are interested in adopting their foster children by ensuring an interview with the foster family care agency. Information gathered from the interview, along with the results of interviews from other prospective adoptive resources, is presented to the appropriate county children and youth agency for review when making a determination on an adoptive family.

This legislation was drafted in response to the concerns of foster parents who feel that they are not given consideration when adoption becomes their foster child's goal. Foster parents are generous and caring and often seek to make the foster child a permanent part of their lives.

Additionally, this measure emphasizes aspects that should be paramount when seeking an adoptive resource for foster children, such as the importance of relatives (kin) to care for the children and the preservation of entire sibling groups. The legislation encourages, as best practice, communication between all parties that have an interest in the well being of the child.

According to the Department of Public Welfare, of the children adopted in Pennsylvania during 2003, 63.7 percent were adopted by their foster parent or parents. This statistic clearly indicates foster parents are being utilized as an effective adoptive resource. This bill reinforces this approach through statute and requires children and youth agencies to be cognizant of the availability of foster parents for permanent placements.

Although some foster parents may not be selected to become the adoptive resource, this proposal seeks to emphasize the significance of foster parents as part of the child's transition team and their important role in the lives of children throughout the Commonwealth.
