Legislation designating English as the official language of the

Commonwealth

In the near future, I plan to introduce legislation that would designate English as the official language of this Commonwealth.

As we all know, the Unites States is a nation which shares many cultures. The citizens of this great land, despite differences, have lived harmoniously together sharing the common goal of a unified nation. One reason this nation has flourished is because of the use of English as a common language. The English language has created a strong bond and has contributed substantially to national unity and societal cohesiveness.

The purpose of my legislation is to preserve, protect and strengthen the unifying role of English as the official language of the Commonwealth. Under my legislation, English would be deemed the official language for official acts of government of the Commonwealth and its municipalities. Under the legislation, there are several instances in which official acts of government are not required to be prepared in English such as when Federal law imposes contrary provisions, in English as a second language instruction and for the promotion of international commerce and tourism.

I should note that this legislation would not infringe on the rights of any individual to choose his or her own primary language. Also, this legislation cannot be used to dictate language policies of businesses in the private sector.
