

Dear Representative Travaglio:

I am requesting your support for retirement legislation which continues the "30 & Out" retirement provision. The provision has been in effect since 1985.

For nearly 15 years, public school employees with 30 years of service had been able to retire without an early retirement penalty. In 1999, this opportunity ended.

I am seeking a restoration of this long-standing pension benefit. This is an elimination of the penalty - not an extra benefit such as the old 10 percent Mellow incentive.

This legislation is good for senior school employees and children.

Thirty years is a long time in any occupation. It is especially important in schools that those needing to retire - due to stress or burnout - have the ability to do so.

This legislation is good for young educators. Thousands of recently graduated education majors are seeking employment. This legislation will open jobs for some, saving districts money and improving the mix of experienced and young educators.

The retirement system can easily afford 30 & Out. The Public School Employee Retirement System, after decades of underfunding, is now overfunded by more than one billion dollars. This amount is growing daily. In 1985 the employer contribution rate was more than 20 percent of payroll. Today, the projected employer contribution rate is 1.9 percent for 2000-2001.

In contrast, our employee contributions have increased over time. All employees hired since July 1983 we contributed 6.25 percent of pay; prior to that the rate had been 5.25 percent. Today it is up to 5.72 percent.

Please support passage of "30 & Out" at the earliest opportunity. Please ask your leadership to move the bill to the floor for action.

Also, I respectfully ask that you please oppose any pension legislation which would increase the multiplier if it does not include school employees.

Finally, I also ask that you oppose any attempt to add unrelated legislation such as tuition vouchers or tuition tax credits. I oppose

Sent 6-27 the use of tax dollars for private school tuition and believe public funds should be invested in public education.

Thirty and Out deserves to be enacted on its own merit and because Pennsylvania's public school employees deserve no less. It should not be passed as part of any deal including vouchers or tuition tax credits.

Your help on this important legislation will be greatly appreciated.

I wish to say also that if a multiplier is introducted for government and state workers, that it should also be applied equally and equitably to teachers as well.

Though we have communicated about this and other issues in the past and you have assured me that you would certainly take my comments into consideration if and when these matters come to a vote, I want you to clearly understand that I respectfully consider it a vital part of your responsibility to do everything within your power to bring these issues to the floor to assure that they are voted on.

Dear Ms Snyder:

Thank you for your letter regarding the retirement needs of public school employees. Your thoughts and concerns are greatly appreciated.

In your correspondence, you mentioned several retirement issues. In relation to the "30 and out" window, I am a cosponsor of House Bills 100 and 420. These measures would entitle an individual to receive a maximum single life annuity without any reduction if they have 30 years of credited service as a teacher or state government employee. House Bills 100 and 420 are currently under consideration by the House State Government Committee.

Regarding an increase in the pension multiplier, House Bill 223 would increase the multiplier benefits on annual accrual rates for existing Class A state government members from 2 percent of their final average salary to 2.5 percent of their final average salary. In addition, employee contributions to the pension fund would increase from 5 percent to 6.25 percent. This legislation would increase these benefits for state government employees, and although it would not specifically cover all school employees, it would cover public school employees who are members of the Public School Employees' Retirement System (PSERS). House Bill 223 is currently under consideration by the House State Government Committee.

On the issue of equalizing employee contributions, House Bill 8, of which I am also a cosponsor, would decrease current PSERS members' contribution rates from 6.25 percent to 5.25 percent. This legislation has been considered by the House Education Committee and awaits further consideration by the full House of Representatives.

Regarding an increase in the retiree medical supplement, I am the prime sponsor of a bill that addresses this issue. Under House Bill 1224, the health insurance premium assistance for eligible PSERS annuitants would increase from \$55 per month to \$162 per month. This legislation is currently under consideration by the House Education Committee.

The years of dedication and hard work that retired teachers have given to the Commonwealth are truly commendable. Thus, the well-being and quality of life for Pennsylvania's retired teachers are of utmost importance to me.

Please know that I will keep your thoughts and concerns in mind if any of the aforementioned bills are brought to the House for a final vote. If I may be of further assistance to you on this or any other matter, please do not hesitate to contact me.

Dear Ms. Hawley:

Thank you for your recent communication concerning early retirement legislation for public school employees commonly known as "30 and Out." As one who believes that 30 years of service deserves the full fruits of retirement benefits, please be assured that I support the concept of "30 and Out" and will give such legislation my utmost consideration when it is before the House of Representatives for a vote.

As you may know, the House Education Committee recently approved legislation sponsored by Rep. Colafella that would create a permanent "30 and Out" retirement option for all public school employees. Rep. Colafella, Democratic Chairman of the Committee, said the measure (an amendment to House Bill 8) would allow teachers to plan for their retirement with greater certainty and allow school districts to better plan for the replacement of teachers.

House Bill 8, of which I am a cosponsor, would also reduce a school employee's retirement fund contribution by one percent, as well as increase health insurance premium assistance for eligible PSERS annuitants from \$55 a month to \$150 a month or the actual monthly premium, whichever is less. The measure is now before the full House of Representatives awaiting further consideration.

Again, thank you for your input. Please be assured that, as the issue of "30 and Out" gains clarity in the days and weeks ahead, I will remain mindful of your concerns relating to any such enabling legislation. If I may be of further assistance with this, or any other issue, please do not hesitate to contact my office.
