Thank you for your recent letter to Governor Schweiker regarding funding for the Red Cross Extended Care appropriation.

As you know, the Governor presented his 2002-03 Executive Budget to the General Assembly on February 5, 2002. Given the current national economic slowdown and its impact on the Commonwealth's General Fund revenues, difficult decisions were necessary to develop a budget that is balanced and realistic. Every effort was made to ensure that funding levels for essential programs and services are adequate to continue effective operations, and we believe this budget accomplishes that goal. The budget proposes to increase spending by only 0.6%. Also, the budget continues the Administration's commitment to tax reductions by proposing to cut taxes for the eighth straight year. In addition to the funding provided for education, health, economic development and the environment, the budget proposes critical new investments in a Homeland Security Initiative designed to strengthen Pennsylvania's emergency preparedness and response capabilities.

While this budget does not specifically include funding for the Red Cross Extended Care appropriation, it does include funding for many other important areas that the Administration believes will benefit the Commonwealth's citizens.

We will remain aware of your support for the Red Cross Extended Care appropriation as we enter negotiations with the General Assembly and the budget is finalized and enacted.

Again, thank you for taking the time to write and express your thoughts on funding for this program and please do not hesitate to bring other matters of concern or interest to our attention.
