
I am presently completing my third term and have been appointed as Vice-Chairman of the Professional Licensure Committee. I am also serving on the Health & Welfare, the Cities-Counties Committees, as well as an Educational Task Force Committee.

Last year I was the sponsor or co-sponsor of thirty-three pieces of legislation. These included a bill for the non-partisan election of school directors, a requirement that the Milk Control Commission make its records public, safety belts and rear view mirrors for cars, a complete revision of the Pharmacy Code, protective election reforms and constitutional amendments.

I have worked closely with the members of my own party and with Governor Scranton in securing the passage of noteworthy administration legislation. In addition I have developed many friends, which have been invaluable in my efforts to serve this district.

A conscientious attitude of participation can be demonstrated by my attendance record. I have missed only two days of last year's session which lasted from January to Christmas - one of the longest in the history of the commonwealth.

I enjoy the planning, the negotiating and the work of the Legislature and believe that each term I become more knowledgeable and competent. I hope to have the pleasure of continuing to serve you.

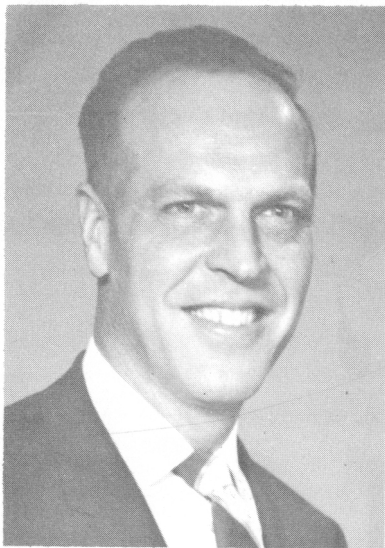
