Q. "What do you mean by the phrase 'The Rebirth of Pennsylvania'?"

A. "I believe it best describes what has happened in Pennsylvania under a Republican administration."

Q. "What has happened?"

A. "Four years ago, Pennsylvania was depressed—nearly bankrupt. The economy was stagnant; people were out of work; the future was bleak. Industry was hesitant to expand or locate here. It appeared Pennsylvania's future was behind it."

Q. "And today?"

A. "Today Pennsylvania is one of the most prosperous states in the nation. We've had an economic rebirth. We're on the move once again."

Q. "What did a Republican administration have to do with this?"

A. "It passed new laws, initiated new policies and ideas. It met problems head-on with long-range solutions, not with passive promises such as characterized the Leader-Lawrence administrations."

Q. "What role did Republican legislators play?"

A. "A major one. Measures were passed

encouraging the growth of industry, tourism and educational opportunities, to provide more effective social services, better government services, and to put the state on a sound financial basis."

Q. "How will Republican legislators help to continue this progress?"

A. "Republicans are committed to Pennsylvania first, politics second. The best politics is doing what is right. Republicans followed their course in spite of fierce Democratic opposition and obstructionism in the boss-controlled House of Representatives. But Pennsylvanians have seen the results. We've had a rebirth. The challenge now is to continue the growth."

Q. "How can this be done?"

A. "Two ways: Pennsylvania needs a Republican legislature to follow through on the start that has been made. One that is oriented towards people and not political machines. Republicans are committed to improving Pennsylvania. Moreover, Ray Shafer and Ray Broderick are pledged to build upon the plans that have been blueprinted."

Q. "What type of plans?"

A. "The \$10-billion highway building program is one; community colleges, better schools and colleges; conservation, natural resources, continued industrial expansion are some others."

Q. "What did Republican legislators have to with the plans?"

A. "Plenty. They had the courage to make every decision from the standpoint of what is best for Pennsylvania. Some reforms, such as unemployment compensation, were bitterly opposed. But Republicans stuck to their guns. Today the jobless fund is healthier than at any time in the past 12 years. Time has proven Republicans were right."



Q. "Dr. Haudenshield what issues are most important to the residents of the new 43rd District?"

A. "Industrial Expansion — which prior to this administration was on the decline in the Chartiers Valley. This could become one of the most prosperous areas in the Commonwealth. Industry means jobs and reduces all levels of local taxes."

Q. "How best can this be accomplished?"

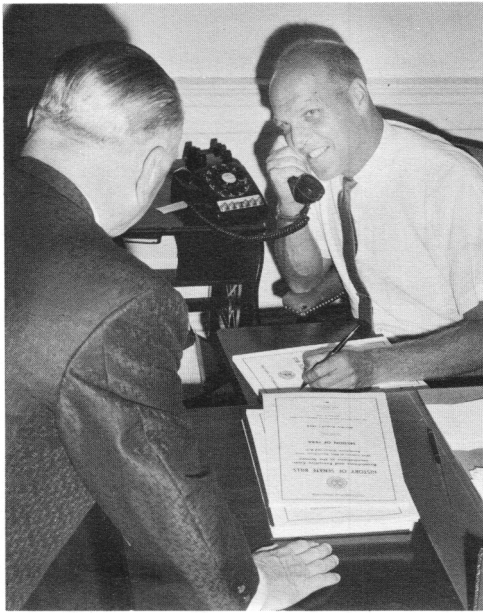

Q. "As a school director are you satisfied with the progress in the field of education?"

A. "Under this administration for the first time in a decade we have twice increased the subsidy to local school districts plus a bonus for teachers from the budget surplus. The Education Committee of which I am a member has initiated, and the General Assembly passed, legislation for Community Colleges, Area Technical Schools, Student Loans and Scholarships and reduced the tuition at Pitt. We pledge to continue this progress."

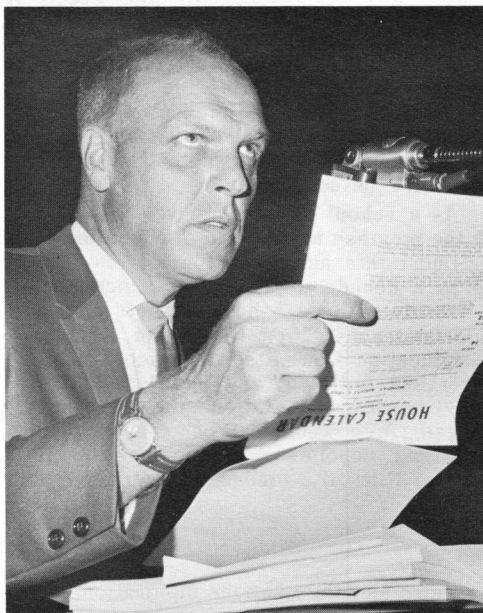

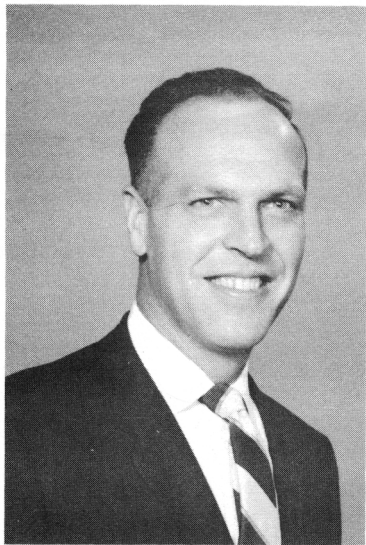

SCHOLARSHIPS AND LOANS

PENNSYLVANIA STATE SCHOLARSHIPS

The Scholarship Program of the Commonwealth of Pennsylvania was created by the 1965 General Assembly to assist qualified students who need financial assistance to attain a higher education.

All scholarship awards are based upon the academic potential of the student as determined by an examination, high school rank in class, or admission to an institution of higher learning, and a need for financial assistance from the Commonwealth of Pennsylvania as determined by the Higher Education Assistance Agency. Financial awards range from \$200 to \$1200 per academic year. There are three main groups or types of awards. Those interested in applying for an award should carefully read this sheet.

GROUP I - ACADEMIC SCHOLARSHIPS

High school seniors entering two or four year degree programs in approved colleges in the United States and those entering approved diploma programs of nursing in Pennsylvania hospitals must compete on the Scholastic Aptitude Test of the College Entrance Examination Board for these scholarships. Approximately 5,000 of the highest scoring high school seniors will be selected annually as semifinalists and will be given an opportunity to make application for one of these academic scholarships. The applications in this category will be forwarded from the Agency directly to the semifinalists. Selection of students to receive financial awards will be made following receipt of the applications and will be based upon test score, rank in high school class, available state funds and need for financial assistance as determined by the Agency. There will be two types of awards in this group; each semifinalist will be given an opportunity to make an application for an award to attend an approved degree granting institution in the United States or an approved diploma program of nursing in a hospital within the Commonwealth of Pennsylvania. The applicant will compete for an award against other applicants in the same category; degree candidates against degree candidates and nursing candidates competing against nursing candidates.

Students who are declared semifinalists in this group (based upon their test score and class rank), but who do not receive a financial award because they are not able to demonstrate sufficient need will receive a Certificate of Merit from the Agency. They will be eligible to apply for a financial award in GROUP I at anytime during their undergraduate years if their need for financial assistance is substantially increased or if additional state funds become available. Semifinalists who do not receive an award in this category and demonstrate financial need, will automatically be considered for an award in the GROUP II scholarships on the same basis as all other applicants and it is not necessary nor permissible to file a second application.

GROUP II - FRESHMEN FINANCIAL NEED SCHOLARSHIPS

Awards in this category will be made to students attending approved degree granting institutions of higher learning in the United States and approved Pennsylvania trade, technical, business schools, and diploma programs for registered nurses. The emphasis on all scholarships in this group is on the students' need for financial assistance and their ability to successfully complete the course of study for which they are enrolled. Interested applicants must obtain a scholarship application available at all secondary schools, institutions of higher learning, and trade, business and nursing schools. If necessary, although it is not encouraged, the applicant may secure an application form by writing directly to the Higher Education Assistance Agency.

High school seniors who plan to attend or are currently enrolled in an approved degree granting institution of higher learning in the United States are eligible to file an application in this group if they score at least 800 (combined Verbal-Mathematics) on the S.A.T. of the College Board.

TRADE, TECHNICAL, BUSINESS AND NURSING SCHOOLS 1965 AND ALL SUBSEQUENT SENIORS

Students who are enrolled or plan to enroll in an approved course of study in any trade, technical or business school within the Commonwealth of Pennsylvania or a diploma program for registered nurses in Pennsylvania hospitals may apply after June 1, 1966 for a scholarship in GROUP II when they have been accepted for enrollment, but not prior to high school graduation. The course of study must offer at least 1800 clock hours of instruction on a full-time basis, require a high school diploma for admission, and be a course of study approved by the Higher Education Assistance Agency under the State Scholarship Program. The students may obtain an application from their high school or institution of higher learning. Applications must be postmarked no later than July 15 of that year.

GROUP III - SPECIAL FRESHMEN AND UPPER CLASS SCHOLARSHIPS

Students enrolled in the sophomore, junior, or senior year of their undergraduate program or students who enter the freshman class with a lapse of at least one calendar year between high school graduation and college enrollment within the Commonwealth of Pennsylvania may be considered for an award in this category.

The financial aid officers of institutions of higher learning will recommend students to the Agency for these awards. Each institution will be permitted to recommend awards with a total value which bears the same proportion to the total appropriation in GROUP III as their undergraduate enrollment of Pennsylvania residents bears to the total population of Pennsylvania residents enrolled in all Pennsylvania institutions of higher learning. These awards will be made to needy students recommended by the institutions and according to the definition of a needy student as established by the Agency.

Awards will be renewed upon the institution's recommendation. The student must maintain an accepted academic record as determined by the institution and continued financial need as defined by the Agency.

GUARANTY LOAN PLAN

The Guaranty Loan Plan provides College Loans to Pennsylvania Residents on the following basis:

The Family of the Applicant must show financial need.

The Student, not his parents, is held liable for the loan.

The loan has no interest during the years of college.

The loan does not have to be repaid until one year after graduation. Then it may be repaid over a ten year period at 3%.

Numerous banks and their branch offices are under agreement to participate in the Guaranty Loan Plan for residents of Pennsylvania who are attending approved institutions of higher learning. These institutions include junior, community, undergraduate, and graduate colleges and universities as well as certain hospital schools of nursing and private trade and business schools. Complete information and application forms are available at all participating banks. Prospective applicants should request the necessary forms and specific information about the loans from a bank in or near their home community. The application must be initiated at a participating bank.

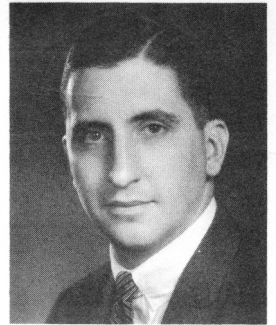

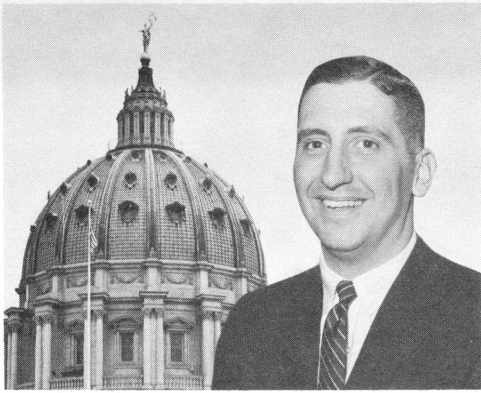

AN ACT

Abolishing the Milk Control Commission and repealing the act by which it was created.

1 THE GENERAL ASSEMBLY OF THE COMMONWEALTH OF PENNSYLVANIA HEREBY
2 ENACTS AS FOLLOWS:

3 Section 1. The Milk Control Commission is hereby abolished and the terms
4 of all present members thereof terminated when this act takes effect.

5 Section 2. The act approved April 28, 1937 (P. L. 417), known as the "Milk
6 Control Law" is repealed.

7 Section 3. This act shall take effect immediately.
