

BILLS SPONSORED BY REPRESENTATIVE GEORGE K. HAUDENSHIELD,
ALLEGHENY COUNTY, 43rd LEGISLATIVE DISTRICT, 1967 SESSION

H.B. 4

Amends Pennsylvania Election Code eliminating straight party voting by ballot and machine.

H.B. 10

Provides for abolishment of Milk Control Commission and repeals law creating it.

H.B. 29

Amends Article II of Constitution as it relates to the Legislature by providing that it be a continuing body and further clarifies disqualifications for holding office.

H.B. 30

Amends Article XVIII of the Constitution as relates to future amendments.

H.B. 31

Amends Article IV of the Constitution as relates to the executive.

H.B. 32

Amends Article VIII of the Constitution pertaining to suffrage and elections.

H.B. 33

Proposes that Articles III, X and XI of the Constitution be consolidated and amended.

H.B. 35

Proposes repeal of Article XVII of the Constitution relating to railroads and canals.

H.B. 63

Provides for regulating sentences imposed for second and third subsequent convictions of felonies and repeals inconsistent acts and parts thereof.

H.B. 74

Provides for attendants on each level of parking lots or garages and fixes penalties.

H.B. 82

Amends Civil Service Act to include State Forest Inspectors.

H.B. 169

Amends State Highway Law further regulating construction of sidewalks in townships and on highways existing along school property.

H.B. 173

Amends Second Class County Code by requiring sealed bids when making certain contracts or purchases.

H.B. 174

Amends Second Class County Code by making editorial correction and providing appropriations to Daughters of Union Veterans of the Civil War for purpose of defraying expenses of Memorial Day and Veterans Day.

Above bill signed into law October 9, 1967 and is known as Act No. 157.

H.B. 184

Amends Pennsylvania Election Code by providing for cross-filing of school director candidates.

H.B. 195

Amends Article XVIII of the Constitution by providing that gasoline taxes and motor license fees may be used for waterways.

H.B. 196

Amends Article IX of the Constitution to exempt persons over 65 with less than \$3500 gross annual income from the payment of certain local real estate and per capita taxes.

H.B. 202

Amends Second Class County Assessment Law to exclude from assessment for a limited period certain repairs and improvements to existing buildings.

H.B. 254

Amends Public School Code of 1949 by providing for increase in number of school directors from nine to fifteen.

H.B. 255

Amends Public School Code of 1949 by requiring a course in driver-education be taught in all high schools.

H.B. 268

Amends Pennsylvania Human Relations Act by requiring leasing of commercial housing to persons requiring the use of guide dogs.

This bill became law on August 11, 1967 and is now known as Act No. 72.

H.B. 271

Provides for abolishment of coroners as county officers and provides the substitution of medical examiners for coroners as county officers.

H.B. 305

Amends Article IX of the Constitution authorizing creation of additional debt and issuance of bonds to finance nonprofit corporations to construct or remodel hospitals.

H.B. 387

Amends Public School Code of 1949 to provide minimum salaries and increments for professional and temporary professional employees.

H.B. 430

Provides for requiring doctors, dentists, chiropractors, osteopaths, RN's, PN's, etc., to have chest x-rays and blood tests and to certify they are free from infectious and contagious diseases.

H.B. 461

Amends Administrative Code by further providing for purchases of handicapped-made products and services.

H.B. 528

Amends Administrative Code to authorize increase in membership of Pennsylvania State Police.

H.B. 540

Amends Public School Employees' Retirement Code by providing for return to school service without loss of annuity.

H.B. 627

Amends Second Class County Code to require maximum salaries be paid to police, firement and fire inspectors within specified period of time.

H.B. 696

Provides for appropriation to Department of State to reimburse extra expenses incurred by various county election boards in submitting the constitutional amendments to electors in 1967 Primary.

H.B. 716

Abolishes County Court of Allegheny and repeals existing laws relating thereto.

H.B. 717

Provides for 6 additional judges in Fifth Judicial District.

H.B. 729

Provides for creation of a regional intergovernmental compact agency in connection with Susquehanna River Basin.

H.B. 736

Amends fuels tax act by changing formula for disbursement of money to municipalities.

H.B. 758

Provides for an appropriation from Motor License Fund to Department of Highways for acquiring and repairing bridge on Old Clairton Road, Allegheny County.

H.B. 764

Provides appropriation to Department of Health for an air pollution sampling network.

H.B. 765

Provides for creation of a Municipal Police Officers' Standards and Training Commission.

H.B. 768

Amends State Highway Law by authorizing acquisition of property necessary for future highway purposes, regulates procedure of acquisition and payment therefor.

H.B. 773

Amends Penal Code by prohibiting sales of glue or adhesive containing toxic or dangerous ingredients.

H.B. 813

Amends Second Class County Code further regulating contributions of counties toward funeral expenses of deceased service persons and widows.

H.B. 818

Amends Vehicle Code to require a brightly colored pennant with word "Learner" on it to be attached to any vehicle being operated by a learner.

H.B. 825

Amends County Code further providing for the classification of counties.

This will sent to Governor for signature on October 17.

H.B. 826

Amends County Code further providing for the classification of counties.

This bill sent to Governor for signature on October 17.

H.B. 833

Amends Administrative Code by changing membership of the Water and Power Resources Board.

H.B. 834

Provides for conservation of water resources, etc., and prescribes duties of Water and Power Resources Board.

H.B. 869

Amends Public School Code by providing for the election of school directors of the 2nd, 3rd and 4th classes by non-partisan ballots.

H.B. 898

Provides to effectuate membership of Pennsylvania in the intergovernmental compact agency providing for the control and abatement of air pollution.

H.B. 899

Provides for planning and regulation of wastestorage and disposal; requires permits for operation of disposal systems; imposes duties on municipalities; creates advisory committee; and provides remedies and penalties.

H.B. 900

Amends Gas Operations Well-Drilling and Coal Mining Act further defining completion of well and provides for operator's responsibility.

H.B. 901

Amends Vehicle Code to provide for inspection of emission control systems and devices.

H.B. 902

Amends Air Pollution Control Act to empower Air Pollution Commission to recommend performance and specification stands for emission control systems.

H.B. 904

Authorizes creation of indebtedness of \$500 milliondollars for the conservation and reclamation of land and water resources.

H.B. 926

Amends Air Pollution Act by changing powers and duties of the Department of Health and Regional Air Pollution Control Associations, sets forth new policy and redefines air pollution.

H.B. 927

Provides for certification of waterworks operators; creates the State Board for Certification of Waterworks Operators and prescribes its powers and duties.

H.B. 928

Provides for certification of Sewage Treatment Plant Operators and creates the State Board for Certification of Sewage Treatment Plant and Waterworks Operators and prescribes its powers and duties.

H.B. 958

Amends Second Class County Code by removing certain provisions rendering persons ineligible for retirement allowance or pension annuity.

H.B. 988

Amends First Class Township Code with respect o construction and payment for sanitary sewers and authorizes tapping fees to be charged for connection with sewers and mains.

H.B. 998

Amends Workmen's Compensation Act by providing additional compensation to be paid to certain totally disabled persons.

H.B. 1052

Provides for regulating the writing, canacellation or refusal to renew policies of automobile insurance.

H.B. 1073

Amends Vehicle Code to prohibit reprint and use for commercial purposes any official copy of vehicle registration, learner's permits issued and other statistics relating to titling and registration of motor vehicles.

H.B. 1114

Amends Municipal Borrowing Law transferring certain powers and duties from the Department of Internal Affairs to Department of Community Affairs.
Signed by Governor October 5, 1967 and is now known as Act 150.

H.B. 1115

Amends Housing Authorities Law providing for dissolution of housing authorities.

H.B. 1116

Amends Municipal Employees' Retirement Law by designating Secretary of Community Affairs as a member of the board.

H.B. 1117

Amends Urban Redevelopment Law to provide for dissolution of redevelopment authorities.

H.B. 1118

Amends act requiring filing of certain reports with Internal Affairs to provide for such filing with Department of Community Affairs instead of Internal Affairs.

Signed by Governor August 11, 1967 and is now known as Act 82.

H.B. 1119

Amends Local Tax Enabling Act transferring certain powers and duties from Department of Internal Affairs to Department of Community Affairs.

Signed by the Governor August 11, 1967 and is now known as Act No. 83.

H.B. 1145

Amends Vehicle Code to require examination of motorcycle operators, further regulating the operation of such vehicles and requires crash bars be installed.

H.B. 1218

Requires that all steel products used in Commonwealth construction work be produced in the United States.

H.B. 1238

Provides for an appropriation to the Department of Public Instruction for intermediate unit planning committees.

H.B. 1239

Amends Public School Code to establish a system of intermediate units, boards of directors and creates the position of executive director.

H.B. 1327

Provides for, where assessment is concerned, exclusion from taxation for a limited period of time certain improvements to real estate by amending the act regulating the assessment subject to taxation.

H.B. 1401

Requires that any bill making appropriation must state source of revenue from which appropriation is to be paid.

H.B. 1412

Amends Dog Law by prohibiting issuance of license unless a dog has been inoculated against rabies at Commonwealth expense, increasing license fees and providing for payment of veterinarians.

H.B. 1424

Proposes amendment to Article IX of the Constitution exempting persons over 65 from the payment of per capita, wage and income taxes and the abatement of certain local real estate taxes.

H.B. 1425

Amends Apprenticeship and Training Act by further defining powers and duties of the council with respect to its advisory function and further prescribing meeting times and duties of the administrative chief.

H.B. 1452

Provides for regulating the business of savings and loan associations.

H.B. 1459

Amends Milk Control Law to authorize any county of the second class, school, hospital, etc. to purchase dairy products from the lowest bidder.

H.B. 1460

Provides for appropriation to Department of Public Welfare for grants to political subdivisions for care of the ageing.

H.B. 1461

Amends Second Class County Code to authorize counties to appropriate funds for traffic control devices.

H.B. 1462

Provides an appropriation to the Department of Public Welfare for demonstration programs at John F. Kane Hospital.

H.B. 1463

Provides an appropriation to the Department of Public Welfare for training courses at John F. Kane Hospital and other institutions.

H.B. 1464

Amends Second Class County Code to authorize counties to appropriate funds for traffic control devices.

Signed by the Governor on October 11, 1967 and is now known as Act No. 198

H.B. 1477

Provides that trustees of State related universities establish a course in dental technology where there are schools of dentistry.

H.B. 1507

Provides for course of instruction for justices of the peace and aldermen.

H.B. 1541

Amends Podiatry Act to further regulate granting of licenses to practice podiatry.

H.B. 1562

Amends Second Class County Code to provide for issuance of non-debt revenue bonds for aeronautical facilities.

H.B. 1566

Provides for meat and poultry inspection, requires licenses and makes certain acts illegal.

H.B. 1573

Provides for method of disposing of records in third class cities, boroughs and townships of the first and second class; establishes a Local Government Records Committee to make rules for disposition of records and assigns certain rules to Department of Community Affairs.

H.B. 1644

Amends Vehicle Code to further regulate posting of local traffic signs.

H.B. 1744

Provides protection of consumer by enabling him to rescind a retail sale of goods or services when sale is made at a place other than at the address of seller.

H.B. 1746

Requires prothonotary to add interest to awards and verdicts in tort actions and fixes prothonotaries' fees.

H.B. 1748

Provisions concern discovery in personal injury litigation of the existence, nature and extent of applicable liability insurance.

H.B. 1772

Amends Magistrates' Court Act further regulating the contents of traffic court summons and disposition of certain traffic court cases.

H.B. 1773

Authorizes law enforcement officers to enter buildings by force to execute warrants.

H.B. 1774

Authorizes police officers to stop and search persons.

H.B. 1776

Amends Vehicle Code by further regulating operation, use and equipment of motorcycles and operators and provides for prevention of noise.

H.B. 1780

Provides Department of Agriculture to fix minimum prices paid to milk producers and to fix other milk prices and repeals certain acts.

H.B. 1819

Amends State Employees' Retirement Code by further defining final average salary for State Police.

H.B. 1859

Proposes amendment to Article IX of the Constitution to provide exemption for certain persons over 65 from school realty taxes and for Commonwealth reimbursement.
