WILL THE MEMBERS PLEASE TAKE THEIR SEATS.

(RAP GAVEL AND WAIT UNTIL MEMBERS ARE RELATIVELY QUIET)

THIS IS THE TIME FOR THE REORGANIZATIONAL MEETING OF THE DEMOCRATIC CAUCUS. OUR FIRST ORDER OF BUSINESS WILL BE THE ADOPTION OF CAUCUS RULES. SINCE NO AMENDMENTS TO THE RULES WERE RECEIVED BY THE CAUCUS CHAIRMAN PURSUANT TO ARTICLE IV RULE #4, WITHOUT OBJECTION THE RULES OF THE 1991-92 CAUCUS SHALL BE THE RULES OF THE 1993-94 CAUCUS. THE CHAIR HEARS NO OBJECTION.

THE CHAIR RECOGNIZES Rep. DAL WHO MOVES THAT ARTICLE III, RULE 2 BE SUSPENDED SO THAT REPRESENTATIVE TOM CORRIGAN IS PERMITTED TO VOTE BY PROXY. THOSE IN FAVOR OF SUSPENDING THE RULES WILL SAY "AYE", THOSE OPPOSED "NO".

THE "AYES" HAVE IT, THE RULE IS SUSPENDED AND REPRESENTATIVE CORRIGAN'S PROXY VOTES WILL BE ACCEPTED.

WE WILL NOW PROCEED WITH THE ELECTION OF THE SPEAKER,

MAJORITY LEADER, MAJORITY WHIP, CAUCUS CHAIRMAN, CAUCUS

SECRETARY, CAUCUS POLICY CHAIRMAN, CAUCUS ADMINISTRATOR AND

APPROPRIATIONS CHAIRMAN.

ALL ELECTIONS SHALL BE BY SECRET BALLOT. AS YOUR NAME IS CALLED, PLEASE COME TO THE FRONT OF THE ROOM AND PICK UP YOUR BALLOT. NAMES WILL BE CALLED IN ALPHABETICAL ORDER. WRITE ON THE BALLOT THE PERSON FOR WHOM YOU ARE VOTING.

PLEASE TEAR OFF THE NUMBER AT THE TOP OF THE BALLOT BEFORE
DEPOSITING IT IN THE BALLOT BOX. HOWEVER, I CAN ASSURE YOU
THAT ALL BALLOTS WILL BE DESTROYED BY THE PARLIAMENTARIAN
IMMEDIATELY AFTER THE ELECTIONS HAVE BEEN COMPLETED.

A MAJORITY OF ALL CAUCUS MEMBERS ELIGIBLE TO VOTE SHALL BE REQUIRED IN ORDER FOR THE NOMINEE TO BE ELECTED. THERE ARE 105 CAUCUS MEMBERS, 53 VOTES WILL BE REQUIRED TO BE ELECTED. IN THE EVENT NO CANDIDATE RECEIVES A MAJORITY OF THE ELIGIBLE VOTES, THE FOLLOWING CAUCUS RULE SHALL APPLY: IF THERE ARE THREE (3) OR MORE NOMINEES, THE NOMINEE WITH THE LOWEST NUMBER OF VOTES SHALL BE DROPPED FROM THE LIST, AND A NEW VOTE SHALL BE TAKEN. WHERE THERE ARE TWO (2) NOMINEES, IF THERE IS A TIE BETWEEN NOMINEES OR IF NEITHER NOMINEE RECEIVES A MAJORITY OF THE ELIGIBLE VOTES, A SECOND (2ND) BALLOT SHALL BE CONDUCTED. IF SUBSEQUENT VOTES FAIL TO BREAK THE TIE VOTE, CAUCUS RULES PROVIDE THE PENNSYLVANIA ELECTION CODE SHALL BE FOLLOWED. EACH NOMINEE FOR AN OFFICE SHALL BE ALLOWED TO SELECT ONE (1) TELLER TO TALLY THE I HAVE ASKED GREG FAJT AND E.J. LUCYK TO ACT AS SECRETARIES FOR TODAY'S CAUCUS. GREG WILL CALL THE ROLL FOR MEMBERS ACOSTA THROUGH LEVDANSKY, AND E.J. WILL CALL THE ROLL FOR MEMBERS LINTON THROUGH YEWCIC. PLEASE PAY ATTENTION AND PICK UP YOUR BALLOT AS YOUR NAME IS CALLED. THEN WRITE IN YOUR CHOICE, TEAR OFF YOUR NUMBER, AND DEPOSIT THE BALLOT IN THE BOX. ARE THERE ANY QUESTIONS? BEFORE WE BEGIN THE VOTING, WE WILL CALL THE ROLL AND ASCERTAIN WHO IS PRESENT. (PAUSE FOR ROLL CALL)

MEMBERS ARE ASKED TO NOT LEAVE THE ROOM UNLESS ABSOLUTELY
NECESSARY. PLEASE KEEP CONVERSATIONS TO A MINIMUM, SINCE IT
IS ESSENTIAL THAT MEMBERS ARE ABLE TO HEAR THEIR NAMES
CALLED.

WE SHALL NOW PROCEED WITH THE ELECTIONS AND THE CHAIR WILL NOW ENTERTAIN NOMINATIONS FOR THE OFFICE OF SPEAKER. NO NOMINATING SPEECHES ARE PERMITTED FOR ANY CANDIDATE AND NO SECONDS ARE PERMITTED.
